This firm and McGwireWoods LLP represent the Official Committee of Unsecured Creditors of Xinerdy Ltd., et al.<sup>1</sup> (collectively, the “Debtors”). We are writing to advise all general unsecured creditors of the court-approved process for filing proofs of claim in these chapter 11 cases.

On June 8, 2015, the Court entered an order establishing certain deadlines to file proofs of claim against the Debtors (the “Bar Date Order”). Pursuant to the Bar Date Order, the deadline to file a proof of claim against one or more of the Debtors is **July 31, 2015 at 4:00 p.m. (prevailing Eastern Time)**.

**The Bar Date Order requires that all proofs of claim be filed by mailing or delivering the Proof of Claim form to American Legal Claims Services, LLC (“ALCS”). The Proof of Claim form is available in electronic format on the website maintained for these cases by ALCS at the address [www.americanlegalclaims.com/xinerdy](http://www.americanlegalclaims.com/xinerdy). A proof of claim will be deemed timely filed only if the original Proof of Claim form is mailed or delivered by hand, courier or overnight service so as to be actually received at the following addresses on or before July 31, 2015 at 4:00 p.m. (prevailing Eastern Time):**


