**AMENDED NOTICE OF PLEADING, DEADLINE TO  
OBJECT OR RESPOND, AND FOR HEARING**

**(Hearing to be Held in Atlanta)**

PMCM 2, LLC, in its capacity as the liquidating trustee (the “**Liquidating Trustee**”) for the Beaulieu Liquidating Trust, has filed the *Liquidating Trustee’s Amended Objection to Request for Administrative Expense Claim Under 11 U.S.C. §503(b)(9) Filed by CM Floor Covering, Inc.* (the “**Objection**”) on January 23<sup>rd</sup>, 2019 [Dkt No. 1063]. Pursuant to General Order No. 24-2018, the Court may consider this matter without further notice or a hearing if no party in interest files a response opposing the Objection on or before February 26, 2019. **If you oppose the relief requested in the Objection, you must timely file your response in opposition to the Objection with the Bankruptcy Clerk** at Clerk, U.S. Bankruptcy Court, 600 E. First Street, Rome, Georgia 30161, and serve a copy on the Liquidating Trustee’s attorney, J. Robert Williamson, Scroggins & Williamson, P.C., 4401 Northside Parkway, Suite 450, Atlanta, GA 30327 by the response deadline. The response must explain your position and be actually received by the Bankruptcy Clerk within the required time.

A hearing on the Objection has been scheduled for **March 5, 2019 at 11:00 a.m. in Courtroom 1402, United States Courthouse, 75 Ted Turner Drive, SW, Atlanta, Georgia 30303**. If a response is timely filed and served, the hearing will proceed as scheduled. If you do not file a response within the time permitted, the Court may grant the relief requested without further notice or a hearing provided that an order approving the relief requested is entered at least one business day prior to the scheduled hearing. If no response is timely filed, but no order is entered granting the relief requested at least one business day prior to the hearing, the hearing will be held at the time and place as scheduled.

**Your rights may be affected. You should read these papers carefully and discuss with your attorney, if you have one in this bankruptcy case. If you do not have an attorney, you may wish to consult one.**
