**NOTICE OF FILING OF REVISED ORDER  
APPROVING RECEIVER/SPECIAL MASTER'S  
RECOMMENDED PLAN OF RESTITUTION AND DISTRIBUTION**

PLEASE TAKE NOTICE that Christopher L. Perkins, the court-appointed Receiver in the above-captioned civil matter, and the court-appointed Special Master in the above-captioned criminal matter ("**Movant**"), filed his Motion and Memorandum In Support of Motion To Approve Receiver/Special Master's Recommended Plan of Restitution And Distribution (collectively the "**Motion**") [Docket No. 75].

At the hearing on the Motion on February 7, 2020, the Court requested the Movant submit a revised order ("**Revised Order**"). Attached hereto are clean and redlined versions of the Revised Order. The revisions consist of the following:

- Attaching redlined and clean copies of the final versions of the Supplemental Settlement and Claims Schedule to the Revised Order;
- Adding language to the Revised Order regarding the approval of the Supplemental Settlement pursuant to which the Investor Victims compromised their claims in order to facilitate a global resolution and distribution scheme to all claimants;
- Resolving the objection of two creditors (one formal and one informal) who had disputed the allowed amount of their claims;
- Highlighting the Plan's estimated distribution percentage in the Claims Schedule to reflect the Plan's estimated **88%** distribution to Investor Victims, and the estimated **50%** distribution to Creditors;
- Clarifying that the Effective Date of the Plan will occur after the Revised Order approving the Plan becomes a final non-appealable order and the Receiver files notice of such on the docket.
- Adding language regarding the transfers of property pursuant to the Supplemental Settlement.

This Notice will be served by electronic mail to all Claimants on the attached service list, as well as published on the Receiver's website at <https://www.americanlegal.com/kiddar>.

**Your rights may be affected. You should read these papers carefully and discuss them with your attorney, if you have one in this case. The Court may deem any further opposition waived, and issue an order granting the requested relief without further notice or hearing.**
