If you mail your written response to the Court for filing, you must mail it early enough so the Court will **receive** it on or before the Objection Deadline.

If a response is not properly and timely filed and served, the Court may deem any opposition waived, treat the Motion as conceded and enter appropriate orders granting the requested relief without further notice or hearing.

PLEASE TAKE FURTHER NOTICE that you should consult the Procedures Orders before filing any written response.

MOTION FOR WITHDRAWAL OF COUNSEL

COMES NOW the law firm of Wolcott Rivers Gates (“**WRG**”), counsel to Richard Arrowsmith, in his capacity as Liquidating Trustee of the HDL Liquidating Trust (the “**Liquidating Trustee**”), appointed pursuant to the confirmed Modified Second Amended Plan of Liquidation (the “**Plan**”) of Health Diagnostic Laboratory, Inc. and its affiliated debtors (“**HDL**”), and respectfully moves the Court for entry of an order substantially in the form of **Exhibit A** attached hereto (the “**Proposed Order**”) granting WRG, including former WRG attorney Diana Lyn Curtis McGraw, Esquire (“**Ms. McGraw**”), relief pursuant to Local Bankruptcy Rule 2090-1(G) to withdraw as counsel for the Liquidating Trustee in each of the adversary proceedings identified in the list attached as **Exhibit 1** to the Proposed Order (the “**Cases**”). WRG states the following in support thereof:
