NOTICE OF FILING OF RECEIVER'S FINAL ACCOUNTING AND MOTION TO TERMINATE RECEIVERSHIP AND DISCHARGE RECEIVER

Christopher L. Perkins, the court-appointed Receiver/Special Master in the abovecaptioned proceedings ("<u>Movant</u>"), pursuant to the October 12, 2018 Receivership Order appointing the Receiver, (i) hereby files the Final Accounting, attached hereto as **Exhibit A** and Standardized Final Accounting Report attached hereto as **Exhibit B**, and (ii) moves the Court for entry of an order terminating the Receivership and discharging the Movant.

1. Pursuant to the December 18, 2020 Order Granting Receiver's Motion For Approval Of Supplemental Settlement, Distribution Plan, and Initial Distribution, the Movant made all remaining distributions to investor victims (\$17,012,411 in total, including the initial distribution) and creditors (\$1,663,729) representing 88% and 50% respectively of such claims, settled and paid all outstanding tax liabilities, and paid all outstanding administrative expenses of the estate. Those activities left the estate with a balance of \$8,032 which the Movant is remitting herewith to the Clerk of Court to be applied in accordance with the outstanding criminal restitution order (Criminal Docket No. 100).

2. Having completed his administration of the estate, the Movant respectfully requests that the Receivership be terminated and that the Movant be discharged in connection with his duties as both Receiver and Special Master.

3. The SEC and United States Attorney have reviewed this Motion and do not oppose the relief sought herein.

4. The Receiver is prepared to attend an in-person, virtual or telephonic hearing or conference with the Court to address questions or concerns that the Court or other interested parties may have.

5. Because there are no novel issues of law presented in the Motion and all applicable authority is set forth herein, the Movant requests that the requirement that all motions be accompanied by a separate written memorandum of law be waived.

6. Notice of this Final Accounting and Motion is being filed simultaneously via CM/ECF as well as the following means:

- *Notice to Investor Victims and Creditors*. The Receiver will serve this Motion on all known claimants and their counsel by electronic mail;
- *Notice by Publication*. The Receiver will also publish notice on his dedicated receivership website maintained by American Legal Claims: <u>https://www.americanlegal.com/kiddar</u>.;
- *Notice upon Inquiry*. Finally, the Receiver proposes to promptly provide a copy of this Motion to any claimant who makes a written request for such documents to the Receiver, the Receiver's legal counsel or the Receiver's electronic mail address: <u>Kiddar@americanlegal.com</u>, or physical addresses.

WHEREFORE, for the reasons stated herein, the Movant respectfully requests that the Court enter

and Order substantially in the form attached as Exhibit C, approving the relief sought in this Motion, and

granting such other relief as is appropriate.
