**AMENDED NOTICE OF MOTION AND HEARING ON

PLEASE TAKE NOTICE that Bruce H. Aquicore LLC (collectively, the “**Receivership Defendants**”), by counsel, will present his Consent Motion for an Order Confirming Settlement (the “**Consent Motion**”).

2. Attend a hearing at **10:00 A.M. (Eastern Standard Time) on a date no later than March 8, 2019** at the United States District Court Eastern District of Virginia, 401

Courthouse Square, Alexandria, Virginia 22314. **If you or your attorney do not attend the hearing, the Court may grant the relief requested in the Consent Motion.**

If you or your attorney do not take these steps, the Court may deem any opposition waived, treat the Consent Motion as conceded, and issue an order granting the requested relief without further notice or hearing.
