RECEIVER'S QUARTERLY STATUS REPORT

Christopher L. Perkins, the court-appointed Receiver in the above-captioned civil matter,

("<u>Receiver</u>"), by counsel, and pursuant to this Court's October 15, 2018 Order, submits the

following report (this "<u>Quarterly Status Report</u>") to the Court.

Procedural and Factual Background

1. On October 5, 2018, the Securities and Exchange Commission ("<u>SEC</u>") commenced this case by filing a complaint (the "<u>Complaint</u>") against certain Receivership Defendants, among others, for violations of federal securities laws. The Complaint requested certain relief, including an injunction against the dissipation of assets, an accounting of assets and liabilities, and a civil penalty.

2. By Order dated October 12, 2018 (the "<u>Receivership Order</u>"), the Court appointed the original receiver and directed him to, among other things, assume control of and take possession of all funds and other assets of the Receivership Defendants. By Order dated December 13, 2019, the Court appointed the undersigned to succeed the original receiver.

3. Pursuant to paragraphs 23 and 24 of the Receivership Order, the Receiver is directed to file this Quarterly Status Report reflecting, among other things, the existence, value, and location of all Receivership Property, and the extent of liabilities.

4. On November 14, 2018, the Receiver filed an Initial Report detailing his activities to date, investigation of assets, and his formulation of a claims process. On January 31, 2019, May 1, 2019, October 30, 2019, and January 31, 2020, the Receiver filed subsequent Quarterly Status Reports. Those reports are incorporated herein.

5. The Receiver files this Report and the attached Exhibits in compliance with the Court's directive:

(a) Summary of the operations of the Receiver.

6. Since the last Report, the Receiver and his professionals have undertaken the following additional activities:

(i) continued investigating, securing possession of, valuing, and marketing for sale
 additional assets of the estates, including certain limited partnership investments of Kiddar
 Capital, LLC, and personal property of Hitt;

(ii) concluded negotiations with ten of the major investors in various Hitt-related investments including the Broad & Washington, Stratford Motor Lodge, Church Road, and Kiddar Triangle commercial properties, as well as the Kiddar Aquicore and WishWould investments, all in the same manner and with same objectives as the Kiddar Herndon Station settlement approved in March 2019;

(iii) concluded analysis of the over 130 creditor claims filed (in a total amount
 exceeding \$144 million), reconciliation of duplicate claims, communication with claimants, and
 consideration of objections to claims;

(iv) formulation of a plan of distribution to creditors and restitution to victims, filing of motion and memorandum to approve Plan; and attendance at hearing;

(v) continued coordination with the SEC, United States Attorney's Office, FBI, andU.S. Probation Office, with respect to the overlap between the criminal and civil proceedings,and impact on the recommended plan of distribution;

(vi) coordination of initial distribution to investor victims pursuant to the Plan; and

(vii) coordination with tax advisor and state and federal taxing authorities regarding final tax returns for various estate entities.

(b) The amount of cash on hand, the amount and nature of accrued administrative expenses, and the amount of unencumbered funds in the estate.

Attached hereto as <u>Exhibit 2.3</u> is a listing of the total cash on hand as of March 31, 2020.

(c) A schedule of all the Receiver's receipts and disbursements.

Attached hereto as <u>Exhibit 2.0</u> is a listing of all such transactions as of March 31,
 2020.

(d) A description of all known Receivership Property including approximate or actual valuations, anticipated or proposed dispositions, and reasons for retaining assets where no disposition if intended.

9. While the Receiver's investigation is ongoing, the attached <u>Exhibit 3.1</u> lists each of the real property assets sold by the Receivership and their values. In addition, the Receiver continues to investigate and liquidate, several investments in technology start-up companies as described on <u>Exhibit 3.2</u>. Finally, the Receiver is investigating, valuing, and liquidating certain personal assets of Hitt as described on <u>Exhibit 3.3</u>. The Receiver intends to dispose of all Receivership property.

(e) A description of liquidated and unliquidated claims held by the Receivership Estate, including the need for forensic and/or investigatory resources; approximate valuations of claims; and anticipated or proposed methods of enforcing such claims.

The Receiver's investigation led to the consummation of the Hitt Family
 Settlement, bringing substantial funds into the Estates and eliminating claims against the Estates.

(f) A list of all known creditors with their addresses and the amounts of their claims.

11. Attached as <u>Exhibits 4.0 and 4.1</u> are lists of the claims filed against and allowed by the Receivership and the approved plan.

(g) The status of Creditor Claims Proceedings, after such proceedings have been commenced.

12. The Receiver's analysis of the claims is complete, and the Court approved the Receiver's Plan of Distribution, including proposed Allowed Claim amounts to all creditors by Order dated February 28, 2020 [Civil Docket No. 136].

(h) The Receiver's recommendations for a continuation or discontinuation of the receivership and the reasons for the recommendations.

13. The Receiver recommends the Receivership continue for a period of up to three months to complete final administration and liquidation of assets, filing of all appropriate tax returns, and issuance of distribution of funds to creditors and victims.
