**DECLARATION OF  
JOHN G. ALBANESE IN  
SUPPORT OF MOTION  
FOR ATTORNEYS' FEES,

I, John G. Albanese, hereby declare as follows:

1. I am one of Class Counsel in the above-captioned matter.
2. I submit this Declaration in support of the Motion for Attorneys' Fees, Costs, and Class Representative Service Award.
3. As outlined in my previous declaration, ECF No. 66, Berger Montague specializes in class action litigation and is one of the preeminent class action law firms in the United States. The firm currently consists of over 60 attorneys who primarily represent plaintiffs in complex civil litigation, and class action litigation, in federal and state courts. Berger Montague has played lead roles in major class action cases for over 50 years, and has obtained settlement and recoveries totaling well over \$30 billion for its clients and the classes they have represented.
4. I am a Shareholder with Berger Montague. I concentrate my practice on consumer protection with a focus on Fair Credit Reporting Act violations, and have served

as Class Counsel in many Fair Credit Reporting Act and other consumer protection matters. I have also prosecuted class actions related to illegal online lending, unfair debt collection, privacy breaches, illegal insurance practices, and other consumer law issues. I am regularly invited to speak on consumer law and litigation issues by the National Association of Consumer Advocates and the National Consumer Law Center, and am an editor of the National Consumer Law Center's Fair Credit Reporting Act manual. I have obtained favorable decisions for consumers in state and federal courts all over the country. I also frequently represent consumer advocacy groups as amici curiae at the appellate level.

5. E. Michelle Drake is an Executive Shareholder at Berger Montague PC. She has been practicing law since 2001 and is a graduate of Harvard College, Oxford University, and Harvard Law School. She serves as co-chair of the firm's Consumer Protection & Mass Tort Department, and as chair of the Background Checks and Credit Reporting Department. Ms. Drake's practice focuses on protecting consumers' rights when they are injured by improper credit reporting, and other illegal business practices. She currently serves as lead or co-lead counsel in dozens of class action consumer protection cases in federal and state courts across the country, including numerous cases brought pursuant to the Fair Credit Reporting Act.

6. Ms. Drake serves on the Board of the Southern Center for Human Rights, is a member of the Partner's Council of the National Consumer Law Center, and is a former Co-Chair of the Consumer Litigation Section for the Minnesota State Bar Association and Board Member of the National Association of Consumer Advocates. Ms. Drake has previously served as a member of the Ethics Committee for the National Association of

Consumer Advocates, and as Treasurer and At-Large Council Member for the Consumer Litigation Section of the Minnesota State Bar Association. She is also an appointee to the Federal Practice Committee in 2010 by the U.S. District Court for the District of Minnesota.

7. Ms. Drake has been named to the LawDragon 500 Leading Plaintiff Financial Lawyers List for 2019, and a 2020 Elite Woman of the Plaintiffs Bar by the National Law Journal, and is consistently named to the annual lists of The Best Lawyers of America, Top 50 Women Minnesota Super Lawyers, and Super Lawyers. She has been quoted in the New York Times and the National Law Journal, and has had prior cases named as “Lawsuits of the Year” by Minnesota Law & Politics.

8. Ms. Drake presents frequently at national and local conferences on class actions, consumer protection, and Fair Credit Reporting Act-related topics, and co-authored a book chapter on background checks and related issues, “Financial and Criminal Background Checks,” Job Applicant Screening: A Practice Guide, Minnesota Continuing Legal Education Publication, May 2014, and the forthcoming 2d. ed. She also was a contributing author to “Consumer Law,” The Complete Lawyer’s Quick Answer Book, Minnesota Continuing Legal Education Publication, 2d. ed., 2019, and “Chapter 1: Case and Claims Selection, Other First Considerations,” Consumer Class Actions, National Consumer Law Center, 10th ed., 2019.

9. Ms. Drake and I have served as lead, or co-lead, class counsel in numerous notable consumer protection matters, including, but not limited to, the following:

*Gambles v. Sterling Infosystems, Inc.*, No. 15-cv-9746 (S.D.N.Y.) FCRA class action, alleging violations by consumer reporting agency, resulting in a gross settlement of \$15 million, one of the largest FCRA settlements to date.

10. Ariana Kiener is an Associate and practices in the firm's Consumer Protection group, where she works primarily on class actions brought under the Fair Credit Reporting Act. She has served as Class Counsel in numerous such matters. Additionally, she has been invited to speak on the Fair Credit Reporting Act by the National Consumer Law Center, and has served as an editor of the National Consumer Law Center's Fair Credit Reporting Act manual.

11. In addition to the above lawyers, Hans Lodge (shareholder with nine years of experience), Joseph Hashmall (senior counsel with 15 years of experience), paralegal Jean Hibray, legal assistant Julie Gionette, and legal project analysts Rachel Brooks and Jocelyn Fena made contributions and billed time to the case.

12. To date, Class Counsel have expended 377.2 hours on this matter, resulting in \$254,120.00 in lodestar calculated at Class Counsel's normal hourly rates. Detailed fee entries are attached hereto as **Exhibit A**, redacted for privilege. Notably, Class Counsel have excluded their time spent solely related to their individual representation of former plaintiff Sharon Dekontee Wright. Class Counsel's lodestar in this matter against the requested fee amount results in a multiplier of 3.1.

13. To date, Class Counsel have also expended \$16,969.63 in out-of-pocket costs that have not been reimbursed. A summary table of those costs is below.

14. Class Counsel's efforts in this matter have included: researching and drafting the Complaint, negotiating and preparing the Joint Rule 26(f) Report and Stipulated Protective Order, researching and drafting the First Amended Complaint, researching and briefing the Motion to Amend, propounding multiple sets of written discovery requests to Defendant (including three sets of Requests for Production and two sets of Interrogatories), engaging in multiple meet-and-confers regarding Defendant's objections to Plaintiff's discovery requests, ultimately negotiating the production of more than 50,000 documents as well as complex data sets on potential Class Members, closely analyzing Defendant's responsive documents and data (which required the retention and management of an expert), preparing for and participating in a full-day mediation with third-party neutral Rodney Max, engaging in subsequent arms-length negotiations, drafting the Settlement Agreement and its Exhibits, obtaining and analyzing multiple settlement administration

proposals, researching and drafting the Motion for Preliminary Approval of Class Action Settlement, and coordinating and overseeing administration of the Settlement.

15. Class Counsel anticipate future work on this matter to include continuing to oversee the administration of the Settlement, responding to Class Member inquiries, researching and drafting final approval papers, and preparing for and arguing at the final approval hearing.

16. Class Counsel's time records are maintained in accordance with industry standards to ensure reliability and transparency. The firm's formal policy requires all timekeepers—including attorneys and support staff—to keep records of time worked contemporaneously and to provide sufficient detail to convey the nature and merit of the work performed. To ensure each time entry contains sufficient detail, Berger Montague requires time entries to include both matter numbers (corresponding to the specific case) and task codes (corresponding to the type of work performed). BMPC uses the widely-accepted ABA Litigation Code Set, which includes 29 task codes spread across 5 stages of litigation (e.g., Pre-Trial Pleadings and Motions, Discovery, etc.) to allocate time to particular tasks. This model, endorsed by courts,<sup>1</sup> ensures that time is billed in a uniform and task-oriented manner.<sup>2</sup> Timekeepers are also required to provide narrative descriptions setting forth the case-specific tasks associated with each time entry.

17. Class Counsel's contemplated fees and costs requests, as well as the Service Award for Plaintiff, were included in all forms of Notice to the Settlement Class. There have been no objections to date from the Settlement Class.

18. The Class Representative played a valuable and active role in this litigation, and devoted significant time and attention to the case. Specifically, he assisted with the investigation of the facts of the case by providing documents and details about his experience, reviewed and approved the First Amended Complaint, and regularly consulted with Class Counsel throughout the litigation, including during settlement negotiations. He also reviewed and approved the Settlement Agreement. Although the case settled relatively quickly after Plaintiff Bingollu was added to the case, Plaintiff Bingollu was fully prepared to participate in the case, including sitting for a deposition and testifying at trial.

19. Currently, the Settlement Administrator has reported that the claims rate is 2.71%. However, this rate is expected to rise, as the Settlement Agreement directs the Settlement Administrator to mail and email a Reminder Notice to those Class Members who have not submitted a Claim Form, at least once no later than 21 days prior to the Claims Deadline.

20. Class Counsel first began investigating the claims at issue in this matter more than three years ago. Throughout their investigation, and since filing this case in December 2021, Class Counsel have pursued this case on a contingency fee basis with no guarantee of any future payment, and have received no payment or reimbursement to date.
